Hereby T2 SRL, as data processor, is always characterized by correctness, lawfulness, transparency and protection of your privacy and your rights.

**ORIGIN AND TYPE OF DATA PROCESSED.** *We process the data you provide that allowed us to identify you in order to enter into contracts and those data that were necessary for the execution, such as name, surname, date and place of birth, personal contact information.*

**PURPOSE OF PROCESSING.** The personal data will be used to fulfill the contract and the legal obligations. The data will also be used to send information, advertising, promotional and commercial material about services and / or products of the same nature. These activities will be carried out exclusively by our internal staff, duly trained on the importance of the protection of personal data, using secure tools that become necessary from time to time. In no case will they be sold to third parties.

**LEGAL BASIS OF TREATMENT AND REVOCATION:** T2 SRL is authorized to process your data to fulfill the contract with you. **DATA RETENTION PERIODS.** Your personal data will be kept for the entire duration of the contract and, from the termination of the relationship, for a further 11 years, unless there is another prevailing reason including: (i) further pending contractual relationship; (ii) a legal obligation that imposes a longer retention period; (iii) need for extension dependent on a judicial gradient.

- o Operate as external managers of the processing, ie contractually authorized parties operating in the name and on behalf of the owner, engaged in the correct and regular pursuit of the purposes described (eg Accountant).
